LAG Arenduskoda area

Geographic scope: Tapa, Kadrina, Haljala, Kuusalu municipalities and Loksa town.


Total area: \sim 1,698 km².

Population: ~23 100 (2025).

Key regions: Includes core of Lahemaa National Park (Estonia's oldest and largest national park, est. 1971, 747.84 km²).

Entreprises: ~ 2,600.

- Agriculture, Forestry & Fishing is the dominant sector, representing covers 17% of enterprises.
- Wholesale & Retail Trade 12%.
- Construction and Professional, Scientific & Technical Activities 11%.
- Manufacturing 9%.
- Transportation, Storage & Other Services 6%.
- Other Sectors 5%.



Key Development Preconditions

- Geographical unity: interconnected municipalities.
- Cultural cohesion: shared traditions and rich cultural life.
- **Economic unity**: diverse economy (agriculture, tourism, processing).
- Social cohesion: similar demographic composition, active communities.
- Lahemaa National Park: the oldest national park in Estonia.

NGO Arenduskoda Funding and Financial Sustainability

- NGO Arenduskoda is a non-profit organization.
- Funding sources include:
- Membership fees,
- Income from economic activities (service fees),
- LEADER program support.
- Additional funding is sought from other funds and programs when possible, including Social Fund.
- Members demonstrate strong interest and commitment, supporting the organization's continuity.
- Membership fees vary by target group, reflecting their financial capacity:
- Local governments pay the highest fees,
 based on population (1.50 EUR per resident).
- Businesses and third-sector representatives pay a fixed fee of 40 EUR.

Sustainable development of the Lahemaa National Park Tourism Area = Arenduskoda area

- The strategy 2019-2024 has been implemented through 3 direct cooperation projects and several other initiatives.
- The total budget managed by Arenduskoda across these 3 projects amounted to EUR 250,000.
- We has been awarded 3 times.
- A total of 18 partners from 8 countries participated in the project cooperation network, including 4 from Estonia, 3 from Latvia, 1 from Lithuania, 3 from Slovenia, 2 from Portugal, 1 from Greece, 3 from Finland and 1 from Slovakia.
- Several stakeholders contribute to the implementation of the strategy.
- The implementation rate of the strategy 2019–2024 achieved is 96%.
- Lahemaa National Park has:
- EUROPARC Sustainable Tourism Charter 2019 (renewal in 2025),
- Green Destination Platinum Level 2023 and Gold Level 2021,
- EUROPARC Business Recongnitions (2023, 2025),
- o Natura 2000 Network since 2004,
- HELCOM Baltic Sea Protected Areas.







New project "GREENPARK"

- The project has 14 partners (LAGs) from 6 countries: Estonia (Arenduskoda, East Harju Partnership, LAG Saarte Koostöökogu, Kodukant Läänemaa), Latvia (Cesis District Rural Partnership, Business Association of North Kurzeme, Partnership of Resekne District, LAG of Society Partnership for rural and sea), Croatia (MURA-DRAVA, Medimurski doli i bregi), Slovenia (Between Snežnik and Nanos, Bogastvo podeželja), Greece (Kenakap SA), and Portugal (ATAHCA)
- The total project budget is approximately €567,000+, with Arenduskoja's budget being €110,000.
- Contributes to the implementation of the Lahemaa National Park strategy 2025-2029.
